Call to Order

The Chairman called the meeting to order at 6:04 p.m.

Approval of Agenda

The Chairman asked that members review and approve the agenda. Mr. Dickinson moved, and Ms. Caldarelli seconded. The Board unanimously approved.

Public Comment Period

There were no members of the public in attendance and the Chairman closed the public comment period.

Consent Agenda

The Chairman asked that members review the Minutes from the September 20, 2022, Board meeting. Mr. Dickinson reported that Mr. Jinks was not included in the list of attendees. The minutes will be amended. There being no additional questions or comments, the Chairman requested a motion to approve the Consent Agenda as amended. Mr. Jinks moved approval and Mr. Beall seconded. The Board unanimously approved.

Finance and Audit Committee Report

The Chairman reported on AlexRenew's clean unmodified opinion from auditors Yount, Hyde & Barbour and recognized Mr. Jinks. He reported that AlexRenew's clean unmodified opinion means the auditor review of the financial statement and the accompanying documents found everything materially in order. He referenced AlexRenew's Federal Single Audit also received an unmodified clean opinion noting it is the highest designation that an organization can receive. He commended the clarity and thoroughness of the audit and the Annual Comprehensive Financial Report.

The Chairman inquired if members had additional comments or questions. There being no additional questions or comments, Mr. Jinks recommended that the Board accept the FY22 Annual Comprehensive Financial Report (ACFR). Mr. Jinks moved and Mr. Beall seconded, the Board unanimously approved the FY22 ACFR.

Unfinished Business

A. CEO (Chief Executive Officer) Search Progress Report

Discussion

The Chairman reported that CEO job notice closed on Friday, October 14. The Board will meet on Saturday, October 22, at 8:00 a.m. to review resumes selected by Polihire. There are approximately seven candidate resumes for review. From this process, the Board will decide which candidates to interview. Interviews will begin on November 12 and run through November 27. He requested that members keep evenings and weekends available for scheduling. Members asked whether the Board would meet again with Polihire and would members be able to review the resumes of unselected candidates. The Chairman reported that the Board will not meet again with the recruiter. Polihire will provide their detailed analysis of each candidate as well as resumes and other pertinent information. The Chairman reported resume information could be made available if the Board requested.

New Business

CEO Monthly Outcomes Reports

Ms. Pallansch referenced her written report and inquired if members had questions or comments. Ms. Pallansch reported that today is the 50th Anniversary of the Clean Water Act. She noted that cleaning water is the reason AlexRenew exists. Future vision has making the water fishable and swimmable for all.

She inquired if members had questions or comments on her two-page written report or the RiverRenew Dashboard.

RiverRenew Dashboard

Work is increasing at the Pendleton Street site (001) as shown on the Look Ahead and referenced on page 3. Staff and the contractor have adjusted the schedule to make up time. The contractor is accelerating the schedule to begin the Pile driving of approximately 250 piles in early November. The piles are needed to support the promenade and other surrounding infrastructure. The piles will be

driven by hammer due to risk management concerns and the contractor has installed monitoring devices to measure vibrations. The pile driving will take approximately four months. Mr. Jinks asked about community outreach to the neighborhood. Ms. Pallansch reported that staff will be available at the site for the first week to inform citizens. AlexRenew has scheduled Sip and Sees, flyer and door hanger distribution, and the Stakeholder Advisory Group (SAG) meeting. She reminded members of the Jamieson Street shutdown for three months in late winter. Tunnel boring begins around October 27th. The Council Board Workgroup meets Wednesday, October 19, at 5:00 p.m. at City Hall in the Council Workroom.

The Chairman referenced page 2 of the Dashboard and noted that 30% of earned value of the project is completed. Ms. Pallansch explained the process of beginning the tunnel boring machine noting that Hazel will not reach full speed, approximately 40 feet per day, until late December. Mr. Dickinson inquired if the tunnel segments are currently on site. Ms. Pallansch reported the segments are not on site due to a lack of storage space. They are currently stored in Maryland. Hazel's progress will be tracked on the Dashboard.

Financial Report

Ms. Pallansch referenced the financial report and inquired if members had questions or comments. Ms. Pallansch referenced page 4 noting the delinquency line is volatile depending on big or small accounts opening and closing as people make payments. She discussed the federal Low-income Housing Water Assistance Program (LIWHAP) being administered by the Virginia Department of Social Services (DSS) for Virginia residents with accounts in arrears. The State received \$22 million for distribution. The Virginia program has opened and AlexRenew has signed the agreement with the State to participate in the program. Promise, the organization that assisted AlexRenew with distribution of CARES Act funding, has been hired by the State to get the money out to water and wastewater utilities for approved customer accounts.

Members inquired about the percentage of eligible residents and debt collections. Ms. Pallansch did not have access to the percentages data and AlexRenew does not refer delinquent accounts to collection agencies. The Chairman asked if there were any additional questions or comments on the financial statement. There being none, Ms. Pallansch reported on AlexRenew's FY22 Annual Report. She referenced a copy in English and a copy in Spanish. She requested that members review the report and return their comments and edits by Friday Noon. Staff will make the changes and have the final version issued by the end of October. The Annual Report is distributed to City Council, Board, AlexRenew peers, libraries and other interested parties. The Annual Report is digitized once it is finalized and sent to HOAs.

There being no additional questions on the Annual Report, the Chairman inquired if there were additional items on the Agenda. Mr. Dickinson noted the EPA Alumni had a session on the Clean Water Act that included a discussion about workforce issues including hiring and retention of operators, engineers and executives and the challenges across the board. Deputy Administrator for Water, Nancy Stoner, was also in attendance discussing the Potomac River.

There being no other business, the Chairman requested a motion to adjourn. Mr. Beall moved and Ms. Caldarelli seconded. The Board unanimously approved. The meeting adjourned at 6:47 p.m.

CEO Board Report October 2022

Dear Members of the Board of Alexandria Renew Enterprises,

The Alexandria Renew Enterprises (AlexRenew) Board of Directors met on October 18, 2022. During the meeting, the Board accepted AlexRenew's Annual Comprehensive Financial Report (ACFR). The fiscal year 2022 financial audit found no deficiencies or material weaknesses in the ACFR.

In October, AlexRenew had one (1) reported case of COVID-19. AlexRenew continues to adapt its policies to ensure that it follows the CDC guidance and complies with Virginia Department of Labor and Industry standards.

The proposed schedule for FY24 Budget and Rate Adjustments is attached. (Attachment 2)

Operational Excellence

Precipitation for October at the Reagan National Airport was 2.78 inches of rain which is below the Washington, D.C. historical average precipitation of 3.40 inches for the month.

Biosolids production for October was 1,503 wet tons, all of which was beneficially used through land application in the Virginia counties of Fauquier, King George, King William, Louisa, Dinwiddie, Frederick, Fluvanna and Buckingham. The biosolids were land applied as Class B biosolids.

AlexRenew met all Virginia Pollutant Discharge Elimination System (VPDES) effluent parameters for October 2022.


RiverRenew is a program owned and implemented by AlexRenew, Alexandria's public regional wastewater treatment provider.

RiverRenew Overview

To improve the waterways that connect us, AlexRenew is implementing RiverRenew to prevent millions of gallons of combined sewage from polluting Alexandria's local rivers and streams each year. Three RiverRenew projects at AlexRenew's wastewater treatment plant are complete. The remaining project includes the construction of a new tunnel to connect AlexRenew's wastewater treatment plant to the four existing combined sewer outfalls in Alexandria.

The Tunnel Project is illustrated on Page 4 of this Dashboard. Construction associated with the Tunnel Project started in early 2021 and will continue through 2025 at five primary locations in Alexandria. The phases of construction at each location are illustrated in the schedule below.







RiverRenew Program Costs to Date


RiverRenew Spend to Date by Locality



Some machines are so excited for a cleaner Potomac they can get a little loud...

...that includes Wayne the Crawler Crane's impact hammer, who will help RiverRenew crews install piles at the Pendleton Street Site beginning in late November 2022.

This critical work will help keep RiverRenew on schedule and provide a sturdy foundation to support the future diversion facility and promenade connecting the community to a healthier Potomac River.

Pile driving uses an impact hammer, which forces steel piles to depths of 100 feet into the soil. Unavoidably, this process emits a repeated hammering sound and may be disruptive to those sensitive to noise.

This work will last through March 2023 and occur between the hours of 9 a.m. and 6 p.m. ET, Monday through Friday.



<u>Overview</u>

Performance of AlexRenew's annual approved budget is reviewed and evaluated monthly to ensure overall organizational financial stability. Audit of FY (fiscal year) 2022 finances has been completed and reviewed by the external auditors and received an unqualified opinion.

Revenues

- FY23 operating revenues totaled \$23.0 million through the end of October with approximately \$19.1 million in Wastewater Treatment Charge revenue and \$3.9 million collected from Fairfax County. Wastewater Treatment Charge revenue is approximately \$1.4 million (7.9%) more compared to the same time period in FY22, and \$2.2 million (12.67%) above the Fiscal 2023 YTD budget. Data indicates an increase month-over-month in customer revenue due to a combination of seasonal trends and the rate adjustment that went into effect on July 1 for FY23. Finance staff will continue to monitor the trend in coming months.
- Revenue performance is primarily driven by billed flows that may be impacted by seasonality and by the Virginia American Water meter reading process, which can vary month-to-month.
- The Fairfax County operating expense charge and IR&R contribution YTD are on budget respectively. Fairfax County capital outlay contributions are also in-line with capital expenditures.





Expenses


FY23 operating and maintenance expenses are \$1.2 million below the year-to-date budget, representing a spend rate of 29.5%. While maintenance costs decreased slightly, chemicals, personnel, utilities, sewage and sludge disposal costs continue to rise mostly due to inflationary pressures.



Capital outlay expenses are \$9.8 million year-to-date, representing a spend rate of 6.6%. At four (4) months into the fiscal year, the overall spend rate is 22.8% of the total budget.



Annual Operating Expenses 3 Year Comparison






Expenditure Budget Comparison By Fund FY 23 vs. 3 Year Average

Delinquencies

The number of accounts delinquent by more than 60 days was 1,260 in October, an increase of 96 accounts month-over-month. The total dollar amount owed to AlexRenew from these accounts totaled \$838,836 at the end of October, an increase of \$103,600 month-over-month. AlexRenew continues to work with customers with unpaid bills to assist them in bringing their accounts current.

Investments

PFM Investment Advisors manages approximately \$21 million of AlexRenew's \$25 million investment portfolio. The following graph demonstrates current earnings on investments of approximately 1.41%; a level higher than general bank deposit earnings rates.



Investment Yield Percentage to Maturity (Investments managed by PFM) Through October 2022


Cash Reserves

AlexRenew's Master Indenture of Trust requires that it maintain a balance on deposit in the Operating Fund equal to not less than 60 days of budgeted operating expenses. AlexRenew's Financial Policy requires a balance on deposit in the General Reserve sub-Fund, also equal to not less than 60 days of budgeted operating expenses. In total, these combined compliance conditions require AlexRenew to maintain at least 120 days cash on hand, and for FY23 this equals a minimum of \$10,008,654 The chart and graph below demonstrate that AlexRenew currently exceeds this requirement.

Operating Fund - 60 Days Required — General Reserve Sub-Fund - 60 Days Required — Actual


Debt Service Coverage

The Indenture also requires AlexRenew to maintain minimum debt service coverage such that Revenues less Operating Expenses or Net Revenues (each term as defined in the Indenture) is at least 1.10x the parity debt service due in any fiscal year. Compliance with Board-approved financial policies require AlexRenew to maintain a higher minimum debt service coverage of at least 1.50x applying the same criteria as defined above.

In both cases, AlexRenew currently exceeds its compliance standard as indicated below. The 2.19x designated in the graph below represents projected coverage for FY23 based on original FY23 budget expectations. At four months into the fiscal year, annualized results would indicate coverage of 2.90x, ahead of the budgeted projection of 2.19x.

Glossary:

Revenue Fund

All revenue receipts of Alexandria Renew are deposited in the Revenue Fund.

The Operating Fund

The Operating Fund accounts for the administration and maintenance of the wastewater treatment system. By Board policy, the Operating Fund shall maintain 120 days of cash in reserve.

Parity Debt Service Fund

The Parity Debt Service Fund shall have deposited in it one-twelfth (1/12th) of the annual required debt payment due within the budget year. Deposits are restricted funds for use to make semiannual payments in accordance with the Alexandria Renew Trust Agreements.

Joint Improvement, Renewal & Replacement (IRR) Fund

The IR&R Fund receives deposits directly from Fairfax County (60% of IR&R budget) and from AlexRenew customer revenue (40% of IR&R budget) for asset renewal of joint use facilities. The contribution to the IRR Fund is 0.7% of the total amount of capital expenditures made subsequent to October 1, 1997, for the joint portion of the system, as set forth by the service agreement with Fairfax County.

Project Fund

The Project Fund records the cost of each joint use capital project included in the AlexRenew Capital Improvement Plans (CIP). The plans for current and future capital projects, both joint and City only, is summarized in a Ten-Year CIP. City use only CIP are accounted for within the General Fund.

General Fund

The General Fund serves as reserve fund to be used for any lawful purpose of the Authority. Deposits to the General Fund are made from the Revenue Fund after all other fund expenditures and requirements have been satisfied. Alexandria Renew principally uses the General Fund to finance specific capital improvements and to provide sufficient reserves in accordance with policy.
