Call to Order

The Chairman called the meeting to order at 6:02 p.m.

#### Approval of Agenda

The Chairman requested that members review and approve the agenda. Ms. Caldarelli moved and Mr. Beall seconded. The Board unanimously approved.

#### **Public Comment Period**

There being no members of the public in attendance and wishing to speak, the Chairman closed the public comment period.

#### Consent Agenda

The Chairman requested that members review the Consent Agenda which contained the Minutes of the July 18 meeting. There being no questions or comments, the Chairman requested a motion to approve the Consent Agenda. Mr. Beall moved and Ms. Caldarelli seconded. The Board unanimously approved.

#### Member and Committee Updates

#### Community Meetings

The Chair reported that the Rosemont HOA is holding a meeting on Wednesday, September 20. He encouraged members to reconnect with their HOA's as Fall approaches.

#### Finance and Audit Committee

Mr. Jinks reported the FY23 audit is in progress.

#### **Governance Committee**

Mr. Beall thanked members for attending last night's meeting. Members reviewed the self-assessment survey for the Board Retreat, approved updates to the Board Roles and Responsibilities and Ethics Policies, and the new Board Orientation Policy. The Overview of Board Committees, Financial, and Environmental Justice Policies have been deferred.

Ms. Sally Magee, Board Retreat facilitator, from Magee Leadership gave a presentation and provided next steps for members in advance of the January Board Retreat.

There being no additional comments, the Committee Chair inquired if moving to approve the updates to the Board Roles and Responsibilities, and Ethics Policies and the new Board Orientation Policies was appropriate. The Chair affirmed and inquired if Ms. Caldarelli had comments, there being none, Mr. Jinks seconded. The Board unanimously approved. Mr. Beall thanked staff and counsel for their work.

#### **Unfinished Business**

The Chair reported new Board Committee assignments for the record. The Finance and Audit Committee is now comprised of Mr. Jinks and Ms. Caldarelli. The Governance Committee is now comprised of Mr. Beall and Ms. Hammer.

#### **New Business**

#### Affordability Presentation and Discussion

#### Discussion

The Chair reported the purpose of tonight's presentation is informational. Affordability is an important issue for AlexRenew and across the nation. Discussion participants included, Mr. Lake Akinkugbe, Director of Finance, Ms. Allison Deines, Chief Water Quality Officer, Mr. Matt Robertson, Communications and Outreach Director, from AlexRenew; Mr. Kelvin Coles, Owner's Advisor, from Brown & Caldwell; and, Mr. Thierry Boveri and Ms. Diana Ling from Raftelis, AlexRenew's rate consultants.

Mr. Carl noted this will be the first Board discussion on Affordability. The presentation defined Affordability. It provided an overview of AlexRenew, current rate drivers; the cost of providing clean water in the City vs. nationally, and reviewed AlexRenew and City programs to support the community. Mr. Carl, staff and consultants provided data on, national and local clean water costs, AlexRenew's current and past delinquency trends; past customer assistance programs for clean water costs; and new ideas to help fund affordability in Alexandria and a discussion on other municipalities' programs. Members discussed the local and federal standards used for determining affordability criteria. Data was provided from various entities including U.S. Census, ALICE, and NACWA. Member inquiries were on the

limitations of the Virginia Water and Wastewater Authorities Act (VWWA) for customer assistance programs. Questions included AlexRenew's billing by usage; and whether stormwater was included in the national and local data numbers. The Board also discussed AlexRenew's past customer service assistance programs, including payment plans, Cares, ARPA and LIHWAP funds distribution. Mr. Carl reported on prior customer assistance efforts including Promise, AlexRenew's H2O Fund, waiving of late fees, and 48 month payment plans. AlexRenew financial policies ensure that rates are set equitably. Mr. Roberts discussed how payment plans work and Mr. Boveri reported on how water shutoffs effect delinquency rates.

Mr. Carl then reviewed the different options for assist customers with Clean Water costs that included . opt-in contribution program, donations, and a PILOT (payment in lieu of taxes program. Mr. Boveri explained how the PILOT program would work.

The Chair requested that the Affordability issue be discussed at subsequent meetings and he thanked staff for the presentation and information.

There were no additional questions or comments, the Chairman recognized Mr. Carl for the CEO Monthly Outcomes Report.

#### **CEO Monthly Outcome Reports**

#### A. CEO Board Report

Mr. Carl noted the CEO Report includes an FY2023 year-end summarization that was added as an attachment. AlexRenew received the \$90 million grant and will begin drawing upon. Staff reported on has projects in the procurement phase for the Solids program and for the preliminary plant improvements, a \$60 million construction project.

Mr. Carl referenced page 2 showing the Job Order Contracts that are in the pipeline with one issued for repair of gravity thickener 3.

Mr. Jinks summarized the end of year statement, reporting AlexRenew ended up in good shape with \$7 million which will assist ratepayers either from capital investment or future allocation. He noted that customers are using more water and staff is billing for more gallons.

Mr. Carl reported the billing transition is ahead of schedule, and staff will implement on November 1, instead of in February. Mr. Robertson will provide an update on the migration at the next Board meeting

Mr. Carl noted items not listed in the CEO Report: three of AlexRenew operators received the Quarter Century Award at the VWEA Conference last week. Mr. Ron Holmes, Mr. Ron Jackson and Mr. Ken Mattson. It was noted they were the only operators that received the award this year and that wastewater treatment provides a career long term. He also recognized Ms. Felicia Glapion, AlexRenew's Chief Engineering Officer, who received the Enslow Hedgepeth Award for her outstanding contributions to wastewater in the region. Both events have been featured in social media and AlexRenew's web page.

#### RiverRenew Dashboard

Mr. Carl referenced the RiverRenew Dashboard noting that staff is working on a letter to send to the General Assembly updating the RiverRenew program and requesting support to move legislation forward to extend the RiverRenew deadline. This is supported by the Virginia Department of Environmental Quality (VDEQ). The letter will be sent to the City for feedback before sending out next week. The Board will also receive a copy prior to sending out. Staff has not

requested a specific date at this time. Staff will work with sponsors to establish a time frame. The current deadline is June30, 2025 and the project is delayed another 30 days since the last letter, which was anticipated.

The project has stopped until mid-October to bring in a booster for the conveyor system. They are also moving the ventilation to the Outfall 002 shaft. Hazel will then be on her way to Outfall 001. We are approximately 6,300 feet in.

Mr. Carl noted a good turnout at the Listening Sessions with over 40 at Outfall 001; fifteen at Outfall 002 and 25 at Hooffs Run. The Mayor announced the Listening Sessions at the Council meeting on Tuesday which improved turnout. Additionally, the Mayor also mentioned the Jamieson Avenue closing for three months to bring the Hooffs Run Interceptor across.

The Chair referenced page 2.1 on the Financials and inquired if the variance on debt proceeds and the Fairfax IRR and Capital contributions is a timing issue. Mr. Akinkugbe reported that it was an issue of timing and is expected to catch up to the budgeted amount.

There being no additional business, the Chairman requested a motion to adjourn. Mr. Jinks moved and Mr. Beall seconded. The Board unanimously approved. The Chairman thanked the team for presentation. The meeting adjourned at 8:24 p.m.

SUBJECT: RiverRenew Construction Stakeholder Advisory Group Reconstitution

#### Issue

The RiverRenew Construction Stakeholder Advisory Group (SAG) will cease to exist on February 18, 2024. RiverRenew construction in the community will continue through 2025.

#### Recommendation

Staff respectfully requests that the Board adopt the attached resolution to reconstitute the RiverRenew Construction SAG as a special temporary advisory group. Reconstitution of the RiverRenew Construction SAG under the Board is recommended to ensure that the existing SAG remains intact and vital community engagement continues through completion of RiverRenew construction in the community.

#### **Discussion**

AlexRenew is implementing RiverRenew, a major infrastructure program to prevent millions of gallons of combined sewage from polluting Alexandria's waterways each year. Since RiverRenew's inception, SAGs have served as a valuable outlet for community engagement and feedback. Three iterations of SAGs have supported all phases of the program as summarized below:

- Ad Hoc Combined Sewer System Plan Stakeholder Group: Established by Alexandria City Council
  in June 2017 and ended in April 2018 as part of the joint AlexRenew and City of Alexandria Long
  Term Control Plan Update completion.
- RiverRenew SAG: Established by Alexandria City Council in October 2018 via Resolution No. 2850 and sunsetted in December 2019 following completion of schematic design for the RiverRenew Tunnel Project.
- RiverRenew Construction SAG: Established by Alexandria City Council in September 2020 via Resolution No. 2959 and extended for two terms via Resolutions No. 3042 and 3126. The RiverRenew Construction SAG held its first meeting on February 18, 2021.

Alexandria City Code Section 2-4-8 states that temporary committees "shall cease to exist upon (i) the completion of its designated task or assignment, (ii) the date it submits its final oral or written report to council, (iii) the expiration of the term specified in the ordinance or resolution creating the committee or of any extension of its original term, or (iv) three years from the date of its initial meeting, whichever occurs first." As such, the RiverRenew Construction SAG will cease to exist on February 18, 2024, reaching its limitation of 1,095 days or three (3) 365-day periods from the group's first meeting.

In light of the SAG's approaching sunset date, the future of the RiverRenew Construction SAG was discussed during its regularly scheduled public meetings held on July 20, 2023 and September 21, 2023. During the discussions, the SAG acknowledged that the current members shared an intimate knowledge of the RiverRenew program and its members expressed a willingness to remain in their roles moving forward — the SAG believed doing so, will help ensure the effectiveness of the group as the project progresses.

If the attached resolution is adopted by the Board, the RiverRenew SAG will be officially reconstituted on February 18, 2024. The sole function of this group will be to serve as a conduit for the transmission of information about RiverRenew construction activities between staff, SAG members, and the community. Current SAG members will be offered the right of refusal to occupy their equivalent seat on the new group and any vacant seats will be left unfilled. The term of the SAG will be for one (1) year and extended annually as necessary in support of RiverRenew activities.

Meetings will be held quarterly and open to the public. The structure of SAG meetings will operate in accordance with Chapter 4 of City Code for Committees, Boards, and Commissions. Notices will be posted publicly in accordance with Freedom of Information Act (FOIA) regulations. The RiverRenew website will feature a SAG portal to serve as a repository for meeting materials, recordings, and notes.

WHEREAS, the City of Alexandria, Virginia Sanitation Authority, d/b/a as AlexRenew, is governed by an appointed five-member citizen board;

WHEREAS, Alexandria City Council established the RiverRenew Construction Stakeholder Advisory Group to monitor the implementation of RiverRenew;

WHEREAS, the RiverRenew Construction Stakeholder Advisory Group held its first meeting on February 18, 2021;


WHEREAS, the RiverRenew Construction Stakeholder Advisory Group will cease to exist on February 18, 2024 per Alexandria City Code Section 2-4-8; and

WHEREAS, the project is still ongoing and staff and the RiverRenew Construction Stakeholder Advisory Group wish to ensure a consistent and continued forum for community input during implementation of RiverRenew.

NOW, THERFORE, BE IT RESOLVED BY THE ALEXRENEW BOARD OF DIRECTORS THAT:

- 1. The RiverRenew Construction Stakeholder Advisory Group will hereby be reconstituted under the AlexRenew Board of Directors for a period of 365 days starting on February 18, 2024.
- 2. All current members will continue to serve on the RiverRenew Stakeholder Advisory Group and any future vacancies within the group will be left unfilled.
- 3. The RiverRenew Construction Stakeholder Advisory Group shall meet quarterly, at a minimum.
- 4. The functions of the RiverRenew Construction Stakeholder Advisory Group shall be to:
  - a. Review and monitor the progress of RiverRenew through construction;
  - b. Communicate the progress of RiverRenew to the community by leveraging existing networks and serve as spokespeople for RiverRenew;
  - c. Serve as a central body for receipt and dissemination of information for RiverRenew; and
  - d. Review and provide recommendations to minimize community impacts.
- 5. Staff will support the RiverRenew Stakeholder Advisory Group.
- 6. The Group will operate its meetings in accordance with Chapter 4 of City Code.
- 7. The RiverRenew Construction SAG shall cease to exist upon (i) the completion of its enumerated functions or (ii) substantial completion of RiverRenew construction within the community, whichever occurs first.




# Customer care system upgrade schedule





#### **Monthly Report**

This report represents a summary of AlexRenew's operational excellence, financial resilience, and public engagement and trust for September 2023.

#### **1** Operational Excellence

#### 1.1 Water Resource Recovery Facility (WRRF) Performance

Performance of AlexRenew's operations is reviewed and evaluated monthly to oversee operational excellence.

Precipitation for the month was 3.60 inches, which is slightly below the historical average precipitation of 3.93 inches for the month.

Biosolids production was 1,974 wet tons. Biosolids were beneficially used through land application in the Virginia counties of Essex, Goochland, Hanover, King George, Louisa, Richmond, and Frederick. AlexRenew met all Virginia Pollutant Discharge Elimination System (VPDES) effluent parameters for September 2023 as outlined in Table 1.1.

#### 1.2 Capital Improvement Program

Specific projects within AlexRenew's Capital Improvement Program (CIP) are highlighted monthly to support operational excellence.

AlexRenew continues to coordinate with the City of Alexandria, JBG, and Clark Construction on the commissioning and turnover of the Innovation District Pumping Station. Turnover is anticipated in October 2023.

On September 11, AlexRenew issued a Request for Qualifications for Construction Manager At-Risk in

support of the Solids Upgrade Program. A pre-proposal meeting was held on September 20 and Statements of Qualifications are due on October 17. In support of the Preliminary and Primary System Upgrades, AlexRenew will be issuing a Request for Qualifications for Construction Manager At-Risk on October 10.

In July 2023, the Board approved three Job Order Contracts (JOC) to support AlexRenew's ongoing construction and maintenance needs. Table 1.2 summarizes task orders issued or pending to the JOC contractors.

#### 1.3 RiverRenew

On September 26, AlexRenew distributed a letter to members of the Virginia General Assembly seeking legislation to extend the RiverRenew statutory deadline of July 1, 2025. Additional updates on RiverRenew are outlined in the RiverRenew Dashboard, provided as Attachment A.

#### 1.4 Safety

Since August 3, 2023, AlexRenew has logged 30,473 hours without a lost time accident.

#### 2 Financial Resilience

Performance of AlexRenew's annual approved budget is reviewed and evaluated monthly to ensure overall organizational financial stability.

#### 2.1 Revenues and Expenditures

Table 2.1 summarizes AlexRenew revenues and expenditures for this period. Major takeaways for this period include:

Wastewater Treatment Charge revenues (\$15.5 million) are trending slightly higher than

- projections due to usage;
- Operating and Maintenance expenditures are trending slightly below projections; and
- Total Expenditures (\$34.5 million) are currently trending lower than projections due to the timing of capital expenditures. This also impacts Debt Proceed revenues (\$12.4 million), since most current capital expenditures are funded through debt, which is also affected by the timing of requisitions.

#### 2.2. Delinquencies




Figure 2.2. Active Accounts 60 or more days Delinquent

Figure 2.2 illustrates active AlexRenew accounts 60 or more days delinquent and total delinquent dollar amount owed over the last three (3) years. Major takeaways for this period include:

- The number of accounts delinquent by more than 60 days increased slightly from the previous period to 1,257 with a total dollar amount owed of \$1,176,931.
- Approximately 61 percent of the delinquency value is from residential accounts.
- Currently, 90 residential and 10 commercial accounts are on active payment plans.

#### 2.3 Board Financial Policy Status

The Master Indenture of Trust (Indenture) and Board Financial Policy require AlexRenew to maintain at least 120 days cash on hand. Additionally, the Indenture requires AlexRenew to maintain minimum debt service coverage of 1.1 times the parity debt service due in any fiscal year. The Board Financial Policy requires AlexRenew to maintain a higher minimum debt service coverage of at least 1.5 times. In both cases, AlexRenew currently exceeds its compliance standards as indicated in Tables 2.3a and 2.3b.

#### 2.4 Investments

PFM Investment Advisors manages approximately \$21 million of AlexRenew's \$25 million investment portfolio. The average yield to maturity as of September 30, 2023, is 2.13%, up eight (8) basis points from the previous month.

#### 3 Public Engagement and Trust

AlexRenew shares a monthly summary of its community engagement and customer service statistics to highlight its contributions to public engagement and trust.

AlexRenew welcomed a total of 255 visitors from the following organizations that hosted meetings on the 6th floor of the Environmental Center in September: Hopkins House (60), Arlington Public Schools (65), Potomac Riverkeeper Network (30), Carlyle Council (10), City of Alexandria (30), Kids' First Years (20), and Virginia Tech Innovation Campus (40).

Customer service received a total of 1,345 calls with 64 percent opting for self-service. The average answer time was 31 seconds. Call center staff answered 130 emails.

On September 12, three of AlexRenew's Senior Operator Technicians were recognized by the Virginia Water Environment Federation as Quarter Century Operators for their service and dedication in a difficult and dangerous profession.


On October 20, AlexRenew staff will be supporting the Alexandria Forum, a renewed City effort, launching with the theme "The Waterfront Revisited - Birth and Rebirth, 1730-2023." AlexRenew has been collaborating with the City to install wayfinding signage as part of restoration efforts associated with the Hooffs Run Interceptor (part of RiverRenew) and a portion of the forum will focus on this signage.

#### **RiverRenew Overview**

To improve the waterways that connect us, AlexRenew is implementing RiverRenew to prevent millions of gallons of combined sewage from polluting Alexandria's local rivers and streams each year. Three RiverRenew projects at AlexRenew's wastewater treatment plant are complete. The remaining project includes the construction of a new tunnel to connect AlexRenew's wastewater treatment plant to the four existing combined sewer outfalls in Alexandria.

The Tunnel Project is illustrated on Page 4 of this dashboard. Construction associated with the Tunnel Project started in early 2021 and will continue through 2025 at five primary locations in Alexandria. The phases of construction at each location are illustrated in the schedule below.


#### **RiverRenew Tunnel Project Schedule**



# RiverRenew Tunnel Project Design-Build Progress









# **RiverRenew Tunnel Project Snapshot**





## Giving Hazel a "boost" to complete her Waterfront Tunnel journey

RiverRenew crews have been working hard at the Royal Street site to prepare Hazel for the next exciting phase of her journey.

This month, RiverRenew crews removed the top half of the Waterfront Tunnel through the Royal Street shaft and installed a conveyor belt booster and ventilation system to support the remaining mile of tunnel construction.

The conveyor booster system will provide the additional "oomph" necessary to convey muck back to AlexRenew, and the ventilation system will bring in fresh air from the surface at the Royal Street site, improving the efficiency of mining operations while ensuring fresh air is circulated for workers.
